Mr. Frick reported that per California Education Code, the District is required to notify employees and/or short term staff permit employees before the end of the school year of the District's decision not to reelect the employee for the next succeeding school year. Ed Code Section 44954 required the Governing Board to notify short term staff permit and/or temporary employees of their employment status for the 2011-2012 school year prior to June 30, 2011. Mr. Frick noted this is a routine action that is taken annually as temporary assignments end and is no reflection on reductions to programs resulting from funding cuts.

Mr. Frick reported that the current state budget requires careful evaluation of all District programs in order to make decisions about necessary reductions due to lack of funding. Categorical funding reductions necessitate site staffing reductions. Fee-based programs which are not self-sustaining after rates have been increased will require reductions or elimination of staffing positions. As a result of staff recommendations, elimination or reductions in hours are recommended. Adoption of the resolution is necessary to implement the reductions. Mr. Frick noted that unfortunately this item is related to funding and as this program is no longer selfsustaining, it is necessary to eliminate the program due to a lack of funding and the impact on the budget. Ms. Klein reported the parents with students enrolled in the District program will be provided with a list of preschool programs in the community that may be able to provide services to the families affected by the closing of the District's preschool program.
