FEATURED PRESENTATION

Performance by the San Dimas High School Wind Ensemble Directed by Daniel Sandt

Dr. Rapkin introduced Daniel Sandt who directed the awardwinning San Dimas High School Wind Ensemble in an excellent performance of two selections from their spring repertoire.

Recognition of the Top Fifteen Elementary School Readers

Lois Klein reported as the District continues to work toward reaching our 90% reading goal, schools use many incentives and rewards to recognize the great work students are doing using Accelerated Reader and Fountas & Pinnell as two of the many tools to measure students' growth in reading. Nannette Hall, Senior Director of Elementary Education and Lucinda Newton, Principal introduced the top fifteen elementary school readers in the Bonita Unified School District. The Board recognized these outstanding students for their achievement.

Recognition of the Student Winner of Congressman David Dreier's Art Competition

Lois Klein reported students from Bonita Unified School District took part in Congressman David Dreier's 2011 Congressional Art Contest, which was open to students throughout the 26th Congressional District. For the second year in a row, a Bonita High School student has won first place in the art competition. Taylor Koedyker, 11th grade won first place honor for her artwork "Let's Not Get Corny". Other Bonita Unified School District students, Megan Lambrecht, 12th grade and Cindy Ontiveros, 12th grade received honorable mentions. The Board recognized these outstanding student artists.

Recognition of the San Antonio Regional Occupational Program Award Winning Students

Lois Klein reported each spring the San Antonio Regional Occupational Program (SAROP) honors students that have been nominated by their teachers as the most successful in their Regional Occupational Program (ROP). Nine Bonita Unified School District students were awarded the Medallions of Academic & Occupational Excellence Certificates of Recognition and Scholarships. Three Bonita ROP students received Los Angeles County Olympic Chapter Scholarships from the Los Angeles County Olympic Chapter which consists of eleven ROPs from Antelope Valley to Long Beach. The Board recognized and congratulated these outstanding students.

FEATURED PRESENTATION-continued

Recognition of Title I Academic Achievement Award to Roynon

Dr. Rapkin reported out of 6,000 California schools which qualify for Title I funding school-wide, Rovnon Elementary School was one of only 209 schools selected to receive the Title I Academic Achievement Award. This award is presented to Title I schools who have successfully closed the achievement gap between students in math and English Language Arts. Roynon Elementary School has not only met its API target school-wide. but has also made significant strides in Title I subgroups. Dr. Rapkin introduced Sean Grycel, Principal of Roynon Elementary School. The Board recognized Roynon Elementary School for receiving this prestigious award and presented to Mr. Grycel for Roynon Elementary School a Certificate of Recognition.

Report on Measure AB Bond Sales

Ann Sparks reported on November 4, 2008, the Measure AB general obligation bond election was conducted successfully. During the campaign for Measure AB, it was anticipated that the tax rate for the taxpayers in San Dimas and La Verne would be \$35 per \$100,000 of assessed property value. During the structuring of the Series B and B-1 Bonds, an analysis was done to see if a different tax rate would save interest costs over the term of the bonds. The analysis indicated that a \$40 tax rate, rather than a \$35 tax rate would provide significant interest savings and a shorter term for the bonds. Based on this analysis, it was determined that it was in the best interests of the taxpayers to increase the tax rate from \$35 to \$40 per \$100,000 of assessed property value. The interest savings generated over the term of the bonds by using a \$40 tax rate, rather than a \$35 tax rate is \$25.5 million. The restructuring also resulted in reducing the overall term of the bonds by four years.

First Reading of Board Policy 3461 – Fund Balance Policy

12046. Motion by Mr. Creiman, seconded by Mr. Coyne, and carried by 5 Ayes, 0 Noes approving first reading of Board Policy 3461 – Fund Balance Policy.

Ann Sparks reported the Government Accounting Standards Board (GASB) has issued Statement 54, Fund Balance Reporting and Governmental Fund Type Definitions, that significantly alters the categories and terminology used to describe the components that compose fund balance. The changes are intended to enhance how fund balance information is reported and to improve its usefulness by establishing new fund balance classifications that are easier for users to understand and apply. GASB 54 is effective for local education agency financial statements prepared for fiscal year 2010-2011. GASB 54 implements a five-tier fund balance classification hierarchy that depicts the extent to which an agency is bound by spending constraints imposed on the use of its resources. In order to implement the classification hierarchy required by GASB 54, it is necessary to adopt a Fund Balance Policy.

Review Preliminary Budget For 2011-2012

12047. Ann Sparks reported that the District budget for 2011-2012 is in the last stages of development. Staff continues to refine the budget information: therefore, the final budget for 2011-2012 may be different than the preliminary budget. Certain basic assumptions have been incorporated into the preliminary budget based on the May Revise announced by the Governor. The final budget will be presented to the Board on June 22, 2011. The District budget will be revised as necessary. ADA revenue limit reduction amounts developed by School Services and CASBO have been incorporated into the preliminary budget. Ann Sparks reviewed the components of the preliminary 2011-2012 District budget and reviewed the revenues and expenditures in the Restricted and Unrestricted General Fund, comparing the 2010-2011 Projected Actuals with the 2011-2012 Preliminary Budget.
