Report on May Revise of State Budget

- 7473. Ann Sparks reported that the May Revise of the state budget was released on May 13. District staff attended a workshop on May 19, 2005, providing details of the budget revision. Ms. Sparks highlighted the major components of the May Revise:
 - 1) Statutory COLA of 4.23%, fully funded;
 - 2) Deficit reduction of 1.002% remains unchanged
 - 3) Shift of STRS retirement costs to District remains unchanged; and
 - 4) Costs for mental health services for special education students are shifted from County government to school districts.

Also included in the May Revise are proposals for expansion, revision or creation of new programs:

- Teacher and principal recruitment, retention and rewards;
- 2) Expanded early career teacher support;
- 3) Career technical education;
- 4) Healthier breakfasts:
- 5) Class size reduction expansion;
- 6) Categorical budget flexibility; and
- 7) Supplemental instruction-High School Exit Exam.

Ms. Sparks presented information and an assessment of the May Revise obtained at the School Services May Revise Workshop, including a comparison of the January State Budget and the May Revise. She reviewed the Governor's refusal to fund Proposition 98 and the components of the \$3.2 billion hit to education.

Adrienne Long, Senior Fiscal Manager made a presentation highlighting the 2004-2005 Estimated Actuals with a 4.23% COLA. Ms. Long reviewed the estimated 2005-2006 Unrestricted General Fund monies, along with a review of the revenues and expenditures and the components of the ending balance.
