Submittal of Smaller Learning Communities Implementation Grant - continued

> Bob Ketterling, Principal of Bonita High School, Kris Kulow, Principal of San Dimas High School, along with Brian Elliot, teacher, and James Eder, teacher, made a presentation on the plan at the high schools to create smaller learning environments. The plan includes developing academic cores for freshman and sophomore students, expanding the Senior Project to include the Junior year. interventions for students who are not working at grade level, linked classes, looping (the same teacher for consecutive classes), developing advisory periods to mentor students and improve their feeling of connection to the school, sequencing courses leading to majors or common skill sets and career connected classes with increased skill building, vocational internships and community service partnerships to give students hands-on work experience to interface with academic curriculum. The award of the implementation of the Grant would provide each comprehensive high school with up to \$160,000 a year over five years to create smaller learning communities within the school. Notification of award of the grant is anticipated to be released in September or November.

Ms. Sparks indicated that the only changes that may occur before adoption of the District budget are in the areas of categorical programs and possible encroachment of Special Education on the General Fund.
