FEATURED PRESENTATION

Report on 2004-2005 Kindergarten
Program

Katy Schneider made a presentation with the assistance of Lois Klein, Senior Director of Curriculum and Assessment on the 2004-2005 Full Day Kindergarten Program. Ms. Klein made a comparison of kindergarten requirements of the past and present. She discussed the program's strengths, which includes State standards for English Language Arts, Mathematics, Science, Social Studies, Physical Education and Visual and Performing Arts. Also included are graphing, counting and tallying, measuring and free choice activities. Dr. Schneider reviewed the results of the kindergarten teacher survey and the student performance data.

Ms. Joanna Beekman, Ekstrand Elementary School kindergarten teacher, introduced her 2004-2005 kindergarten student, Delaney Townsend who read examples of her writing to the Board of Education.

Doris Chovan, Oak Mesa Elementary School Kindergarten teacher addressed the Board and noted changes in kindergarten over the past 29 years that she has been a teacher. Ms. Chovan reported on her positive experience and the successes and challenges of this school year, having participated in the Full Day Kindergarten Program. She noted that extra planning and preparation time are critical to the program.

Dr. Schneider and Alice Murphy, Director of the School Age Care Program made a presentation regarding a pilot program for a district full day preschool program for the 2005-2006 school year. Highlighted in the presentation was an overview of what is involved in implementing the program, the standards-based via an experiential play-centered curriculum, the program's goal, location, proposed timeline and funding. The pilot preschool program will be self-supporting, with all operational costs provided by parent tuition.

Ms. Latourelle expressed concern that preschool children might not be able to function in a full day preschool setting; and whether the program would be a valid preschool or a day care facility.

George King, teacher, suggested that the District explore the possibility of a parent-participation preschool program.

Susan Holcomb, parent, addressed the Board regarding the proposed preschool program. She expressed that it is her opinion that a good foundation provided by a preschool program for students entering kindergarten would be valuable for the students. She indicated as a parent she supports a preschool program in the District.
