Tentative Agreement between BUSD & BUTA

- 9648. Approved the Tentative Agreement between the Bonita Unified School District and the Bonita Unified Teachers Association, effective July 1, 2007. Included in the Tentative Agreement was approval of:
 - Total compensation-a 4.53% salary increase retroactive to July 1, 2007
 - One-Time Early Retirement Incentive-increase from \$2,000 to \$6,000 Early Retirement Incentive for those retiring this year only. The requirement is for the benefit to be cost neutral to the District.
 - 2008-2009 School Calendar
 - Payroll-District will implement an 11-month payroll cycle for all bargaining unit members, effective, July 1, 2008
 - Speech and Language Pathologists-effective July 1, 2007 the minimum salary schedule placement for Speech and Language Pathologists shall be Column VI, Step 13.
 Speech and Language Pathologists shall receive 8% above their salary schedule placement

Revised Salary Schedules for Certificated Non-management Employees

9649. Approved revised salary schedules for certificated non-management employees reflecting a 4.53% salary increase, effective July 1, 2007

STUDY SESSION BUSINESS SERVICES

Possible Bond Measure

9652. The Board engaged in a study session to determine the feasibility of a possible Bond Measure.

Ann Sparks presented a comparison of potential bond proceeds and project costs. She reviewed the pros and cons of pursuing another General Obligation Bond.

Mark Rosson and Steve McGuckin, representatives from CPM provided a presentation on the thirteen projects that would be included in the Bond with an overview of Historical Background; Evaluation and Update on the Projects' Scope; Conceptual Project Budgets including Project Budget Components; and a Proposed Master Program Budget, including Components; Proposed 2008 Bond Projects Master Program Budget and items for consideration.

Charles Youtz, a representative from George K. Baum and Company provided a Preliminary Financial Analysis for the District on a 2008 General Obligation Election. Information presented included the District's Assessed Valuation, Education Code/Government Code Tax Rate Scenarios and supporting information. Mr. Youtz will provide information to the Board on conducting a community survey.
