> Ann Sparks reported that one of the provisions of Education Code Section 42127 (AB 1200, 1988) requires that school districts participating in the single budget adoption cycle, revise adopted budgets within 45 days of the approval of the State Budget. The State Budget was signed by the Governor on September 16, 2008. Changes to the Unrestricted General Fund revenue budget totaled \$585,914 in the areas of Revenue Limit Sources, Hourly Programs, Lottery Revenue, 9th Grade Class Size Reduction, Reduction in Encroachment and Other Local Income. Changes to the Restricted General Fund revenue budget totaled \$444,852 in the areas of NCLB. Title 1. NCLB Title II. Part A. NCLB Title V, Part A, Workforce Investment Act, Lottery-Proposition 20-Instructional Materials, ROP Apportionment, California Instructional School Gardens Carryover, Economic Impact Aide-Deferred Revenue, Home to School Transportation, High Priority Schools Grant Program, Certificated Staff Mentoring Grant, Targeted Instructional Improvement Block Grant, K-12 Educational Technology-Microsoft Settlement, and Reduction in Encroachment.
