#### **COMMUNICATIONS-BOARD/SUPERINTENDENT**

Mr. Elliot reported attending the District-wide staff development day and commented on the good work that was completed on that day. She reported attending Shull Elementary School's visit and said it was very exciting and enjoyable. Ms. Koach congratulated Chloe Mouawad for her accomplishment as a published author. Ms. Koach congratulated teachers who were awarded the La Verne/San Dimas Educational Foundation Mini-Grants. She noted that information on the Foundation can be found on the District website. She reminded everyone that March 30<sup>th</sup> is the Golf Tournament. On Friday, March 23 at 5:00 p.m. Gladstone Elementary School will hold its annual Kindergarten Circus and invited everyone to attend.
