1. ELPAC Testing (English Learners)	Nancy Sifter - State Testing for English Learners. Approximately 11% of students need to be tested at this point. Testing window has been extended through July 30th. Results may be delayed due to an extended testing window.

Chris Ann Horsley - Review of the current plan, ; six specific goals to increase learning, address learning loss and student well-being/mental health issues. There are actions under each goal; explanations of the actions to be taken to achieve each goal. Some of the goals to be included are; Intervention Opportunities, Behavioral Health, Parent Education Programs and High Quality Curriculum for staff development. The attached link has all the detailed information.

5. Consolidated Application Spring Submission

Nancy Sifter - Overview of the CONAPP for Title, I, II, III, and IV funding. I- Low Income, II- Professional Improvement, III- English Learners and IV- Student Support and Academic Enrichment. The application opens on June 1 and will be due approximately six weeks later. Reviewed allocations and expenditures.

6. Expanded Learning Opportunities Grant (ELO)

Matt Wien - Funds related to COVID-19. The district allocation is \$6.4 million. On June 1st the ELO plan will be presented to the Board of Education. The plan will explain how BUSD will use the funds it receives to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level. The development of the plan included input from district staff, parent advisory groups, a parent survey that yielded approximately 2000 responses. The funds will be expended on the following:

1. Increase Mental Health Supports
2. Increase Intervention
3. Robust Summer School 2021 and 2022. (This year there will be up to 3,000 students on campuses during various summer programs.)
4. Increase Paraeducators (additional aides will be hired to provide support for lost learning)
5. 15% set-aside for Remote Learning 2021-2022 School Year. Although the District is planning on returning to offer 100% in-person learning, remote-option
