## PEERS® Social Skills Group for Adolescents

Cristal Workman and Carmen Morell, School Psychologists at Ramona Middle School, have put together two PEERS Social Skills Group for Adolescents. This is an evidence-based social skills intervention targeted towards teens. These teens are taught social skills through didactic lessons and role-play demonstrations where these skills are practiced during online socialization activities. Student cohorts attend 14 weekly telehealth sessions over Zoom for 75 minutes each week. Each week is broken down into topics:

- Using social media and online platforms to develop and maintain friendships
- Conversational skills
- Entering and exiting conversations
- Electronic communication
- Using humor appropriately
- Organizing get-togethers
- Being a good sport
- Handling disagreements
- Changing a bad reputation
- Handling teasing and bullying
