Dear Parent or Guardian,

We would like to inform you that an Integrated Pest Management (IPM) approach for controlling insects, rodents, and weeds will be used at Bonita Unified School District. The IPM approach we will be using focuses on making the school buildings and grounds an unfavorable place for pests to live and breed. Through maintenance and cleaning, we will reduce or eliminate available food and water sources, and hiding places for the pests. We will also routinely monitor the school area to detect pest problems and prevent the pests from becoming established. Some IPM techniques we will employ include monitoring, increased sanitation, sealing entry points, physically removing the pest, and modifying storage practices.

The Healthy Schools Act requires all California school districts to notify parents and guardians of pesticides they expect to apply during the year. We expect to use the following pesticides in your school this year:

Bayer Deltadust insecticide, Bayer Finale herbicide, Bayer Premise 2 insecticide, Bayer Premise Foam for termites, EcoPCO aerosol unscented insecticide, EcoPCO AR-X aerosol insecticide, NiBan-FG silverfish solution, Onslaught insecticide, Speed Zone herbicide for turf, Syngenta Advion cockroach gel bait, Syngenta Advion fire ant bait, Vector Pro Poison Free Flushing and contact killer, and Hot Shot Roach Powder.

In addition, the Bonita Unified School District periodically contracts with Janus Pest Control or The Beekeeper for bee management. This generally does not require the use of a pesticide.
