Section I—RFP Overview

A. Company Description

The Bonita Unified School District is located in the Cities of San Dimas and La Verne in Los Angeles County and is divided into various departments and thirteen (13) school sites.

B. RFP Objectives

Through this Request for Proposal (RFP), the Bonita Unified School District (DISTRICT) is soliciting proposals for the provision of networked print device management services on DISTRICT owned printer devices. Alternate pricing for networked **and** stand-alone print devices is also being requested. Copiers/multi-function devices and fax machines are generally not included within the scope of services requested in this RFP. Service response times are expected to be within a four hour maximum onsite timeframe. There will be a few sensitive areas that will require a more rapid response time (i.e. two hours or less onsite) which would generally be the exception, not the rule. The DISTRICT CIS Department reserves the right to respond to printer service requests during critical situations.

Specifically, the DISTRICT hopes to accomplish the following objectives:

- Optimize its printer fleet (as it pertains to service and supplies in an effort to reduce operating costs, increase business productivity and improve on the environmental impact)
- Obtain premium customer service and implementation assistance through dedicated account management, implementation project management and skilled technical support
- Significantly reduce cost
- Receive high service/supply quality and responsiveness
- Streamline its equipment service and supply procurement and maintenance process

C. General Conditions

This RFP is not an offer to contract. Acceptance of a proposal neither commits the DISTRICT to award a contract to any supplier, even if all requirements stated in this RFP are met, nor limits our right to negotiate in our best interest. The DISTRICT reserves the right to contract with a supplier for reasons other than lowest price. We will thoroughly examine each proposal for best price, product quality, performance measures, flexibility and customer support.

Proposals are to be made in good faith, without fraud, collusion or connection of any kind with any other contractor for the same work. All proposers must complete in their own interest and in their own behalf. If you are subcontracting any portion of this agreement, you must identify the subcontractor in your proposal and agree that all subcontractors are bound to all terms and conditions of this RFP.

The proposer will absorb all costs incurred in the preparation and presentation of the proposal.

The DISTRICT reserves the right to reject any or all proposals, in whole or in part, with or without cause, even if all the stated requirements are met. At the sole discretion of the DISTRICT, proposer presentations may be requested before award of the contract. DISTRICT may also request the opportunity to conduct an on-site review of the supplier's facility and/or other locations where these services are provided, or a demonstration of the proposed technology.

D. Confidentiality

The DISTRICT will treat information received from your company as confidential or proprietary only within the context of our being a public agency subject to public scrutiny or requests for information submitted and allowed for by law under the California Public Records Act.

E. Contract Term

For the purpose of this RFP, any contractual period will be for a maximum of 60 months in 12 month increments.

F. Proposal Effective Period

Proposers shall state in writing that all furnished information, including prices, will remain valid for 120 days from the date proposals are due.

G. Evaluation Criteria

Section II—Current State

A. Background Information

An itemized equipment list by DISTRICT location is included in Attachment 1. Please note that this inventory is several months old and should be considered representative of the devices currently in use.

B. Scope of Services

DISTRICT seeks a supplier who can provide service and supplies to existing DISTRICT networked printers in an efficient, consistent manner. Proposals must allow for additions and deletions to the printer fleet. Vendor suggestions regarding the scope of devices as well as financing/leasing options are welcomed.

DISTRICT currently has over 600 laser jet printers. These printers include models from Dell, HP, Kyocera, and Canon.

DISTRICT is interested in attaining maintenance service and supplies that will best serve our end-users, while addressing the business needs of each department and minimizing cost. At a minimum, vendor shall provide the following:

- Vendor provides repair service during Bonita USD's business hours of 7:00am – 4pm M/F.
- On-site service within four hours of the problem being reported. Problems reported after 2:00 PM will be addressed by 10:00 AM the following business day.
- Summary email of work performed as service call is completed shall be sent to the district.
- Preventative maintenance is to be performed on a regular and scheduled basis.
 - The vendor's proposed approach to this preventative maintenance is to be clearly articulated in the vendor's response to this RFP.
- Final resolution of issues within 1 week.

The contractor shall provide a toll-free number that the DISTRICT can contact to report printer problems. The vendor shall sufficiently staff their help desk so that a minimum of 90% of the calls from the DISTRICT (made between the hours of 7:00 AM and 4:00 PM) are answered by a vendor employee, not by an answering service or voice mail. We are interested in creative solutions that include the following:

- Automated supply replenishment and service need notification
- Service/maintenance of printers

- Printer supplies
- Technical expertise capable of supporting the DISTRICT’s printer fleet
- Reporting (total pages printed, black and white pages printed, color pages printed, printer efficiency, list of all service / maintenance performed on a DISTRICT printer by vendor, etc.)

The contractor provided maintenance of printers shall meet the following requirements:

- Vendor shall maintain an inventory of replacement printers that meet the fleet requirements of the District to facilitate 1 week repair requirement.
- Replacement toner shall shipped to the school site when the toner level is 10% remaining.
 - Vendor shall facilitate recycling of toner.
- Vendor shall maintain an accurate inventory of deployed printers within the district.
- Vendor shall provide a monthly report of service calls to the district describing all onsite visits and remote work performed.
- Vendor shall be required to swap out printers deemed not repairable.
- Vendor shall be required to replace printers that are older than 7 years old.

All Fleet printers meet the following requirements:

- Capable of duplex printing.
- Network attached.
- Supporting centralized administration.
- Laser Only (non inkjet/bubble jet)
- “Business class” printers.
- Preferred Manufacturer
 - HP
 - Xerox
 - Kyocera

In addition to fleet requirements, the following printer scenarios are envisioned and should be addressed as part of any proposal

This Agreement is made between the Bonita Unified School District, 115 W. Allen Ave, San Dimas, California 91773 (DISTRICT) and _____ (CONTRACTOR).

RECITALS

WHEREAS, Contractor is specifically skilled, trained, experienced, and competent to render the services and advice described in Section 1 hereof, and

WHEREAS, District requires the services described in Section 1 hereof and District is unable to obtain said services from existing personnel, and

NOW, THEREFORE, District and Contractor mutually agree as follows:

1. Services to be Provided by Contractor:

CONTRACTOR agrees to provide: _____

CONTRACTOR shall perform the CONTRACTOR'S work in accordance with currently approved methods and standards of practice in the CONTRACTOR'S professional specialty.

2. Term of Agreement:

This Agreement shall commence _____, 20____ through _____, 20____, unless said work is completed on a date prior thereto or unless terminated earlier as provided herein or extended upon mutual agreement.

3. This Agreement shall not be interpreted in favor of any Party by virtue of said Party not having prepared this Agreement.

If any time period provided for in this Agreement ends on the day other than a Business Day, the time period shall be extended to the next Business Day.

4. Compensation:

DISTRICT agrees to pay CONTRACTOR an hourly amount of (\$). The total payments made for services performed pursuant to this Agreement shall not exceed _____ DOLLARS (\$00,000.00).

5. Invoicing:

CONTRACTOR shall submit one original invoice to the DISTRICT. All invoices must reference this Agreement Number/Contract ID # and the service performed. Payments shall be made within 30 days of receipt of invoice from CONTRACTOR.

6. CONTRACTOR'S Status:

In the performance of work, duties and obligations imposed by this Agreement, the CONTRACTOR is at all times acting as an Independent CONTRACTOR practicing his or her profession and not as an employee of the DISTRICT. **A copy of CONTRACTOR'S current professional, local, state or other business licenses required to conduct the services stated herein, will be provided to DISTRICT.** The CONTRACTOR shall not have any claim under this Agreement or otherwise against the DISTRICT for vacation, sick leave, retirement benefits, social security or workers' compensation benefits. The CONTRACTOR shall be responsible for federal and state payroll taxes such as social security and unemployment. DISTRICT will issue a Form 1099 at year- end for fees earned.

7. Assignments:

Inasmuch as this Agreement is intended to secure the specialized services of the CONTRACTOR, CONTRACTOR may not assign, transfer, delegate or subcontract their obligation herein without the prior written consent of the DISTRICT. Any such assignment, transfer, delegation or subcontract without the prior written consent shall be considered null and void.

8. Non Exclusive Rights:

This Agreement does not grant to CONTRACTOR any exclusive privileges or rights to provide services to DISTRICT. CONTRACTOR may contract with other counties, private companies or individuals for similar services.

9. Indemnification:

CONTRACTOR shall, at its expense, defend, indemnify and hold harmless the DISTRICT and its employees, officers, directors, contractors and agents from and against any losses, liabilities, damages, penalties, costs, fees, including without limitation reasonable attorneys' fees, and expenses from any claim or action, including without limitation for bodily injury or death, to the extent caused by or arising from the active and/or passive negligence or willful misconduct of CONTRACTOR, its employees, officers, agents or Subcontractors.

CONTRACTOR shall hold the DISTRICT, its officers and employees, harmless from liability, of any nature or kind on account of use of any copyrighted, or un-copyrighted composition, secret process, patented or un-patented invention articles or appliance furnished or used under this order.

10. Insurance:

CONTRACTOR, shall submit proof of insurance with liability limits as set forth below to the Purchasing Department showing DISTRICT, its officers, employees, agents and volunteers named as Additional Insured to include ongoing operations and products completed operations (On Additional Insured Endorsement CG 20 10 10 93), except for Workers' Compensation and professional Liabilities, and insurance policy shall contain provisions that such policy may not be canceled or reduced except after thirty (30) days written notice to the DISTRICT. The DISTRICT at its discretion, may waive in part or in full insurance requirements. CONTRACTOR is required to provide insurance unless notified by the DISTRICT'S Purchasing Agent of any waivers.

CONTRACTOR agrees that CONTRACTOR is responsible to ensure that the requirements set forth in this article/paragraph are also to be met by CONTRACTOR'S subcontractors/CONTRACTOR'S who provide services pursuant to this Agreement. Copies of insurance certificates shall be filed with the DISTRICT'S Purchasing Agent.

11. Discrimination:

CONTRACTOR shall not discriminate because of age, ancestry, color, creed, marital status, medical condition (cancer or genetic characteristics), national origin, physical or mental disability, political affiliation or belief, pregnancy, race, religion, sex (includes sexual harassment) and sexual orientation.

12. ADA Compliance:

CONTRACTOR shall comply with the Americans with Disabilities Act (ADA) of 1990, which prohibits discrimination on the basis of disability, as well as all applicable regulations and guidelines issued pursuant to the ADA. (42 U.S.C. Sections 12101 et seq.)

13. Notices:

Any notice required to be given pursuant to the terms and conditions hereof shall be in writing, and shall be effected by one of the following methods: personal delivery, prepaid Certified First-Class Mail, or prepaid Priority Mail with delivery confirmation. Unless otherwise designated in writing by either party, such notice shall be mailed to the addresses shown on page one (1) of this Agreement.

14. Termination:

If the CONTRACTOR breaches or habitually neglects the CONTRACTOR'S duties under this Agreement without curing such breach or neglect upon fifteen (15) working days written notice, the DISTRICT may, by written notice, immediately terminate this Agreement without prejudice to any other remedy to which DISTRICT may be entitled, either at law, in equity, or under this Agreement. In addition, either party may terminate this Agreement upon thirty (30) days written notice to other party.

If the DISTRICT Board of Supervisors fails to appropriate funds to enable DISTRICT Departments to continue to make purchases under this Agreement, this Agreement will be cancelled immediately and CONTRACTOR will be given written notice of such termination.

15. Conflict of Interest Statement:

CONTRACTOR covenants that CONTRACTOR, its officers, employees or their immediate family, presently has no interest, including, but not limited to, other projects or independent contracts, and shall not acquire any such interest, direct or indirect, which would conflict in any manner or degree with the performance of services required to be performed under this Agreement. CONTRACTOR further covenants that in the performance of this Agreement no person having any such interest shall be employed or retained by CONTRACTOR under this Agreement. CONTRACTOR shall not hire

DISTRICT'S employees to perform any portion of the work or services provided for herein including secretarial, clerical and similar incidental services except upon the written approval of DISTRICT. Performance of services under this Agreement by associates or employees of CONTRACTOR shall not relieve CONTRACTOR from any responsibility under this Agreement.

16. Drug Free Workplace:

CONTRACTOR shall comply with the provisions of Government Code Section 8350 et seq., otherwise known as the Drug-Free Workplace Act.

17. Force Majeure:

It is agreed that neither party shall be responsible for delays in delivery, acceptance of delivery, or failure to perform when such delay or failure is attributable to Acts of God, war, strikes, riots, lockouts, accidents, rules or regulations of any governmental agencies or other matters or conditions beyond the control of either the CONTRACTOR or the DISTRICT.

18. Compliance:

CONTRACTOR shall comply with all federal, state and local laws, regulations and requirements necessary for the provision of contracted services. Furthermore, CONTRACTOR shall comply with all laws applicable to wages and hours of employment, occupational safety, fire safety, health and sanitation. CONTRACTOR shall maintain current throughout the life of this Agreement, all permits, licenses, certificates and insurances that are necessary for the provision of contracted services.

19. Governing Law and Venue:

The Laws of the State of California shall govern this Agreement. Venue is Los Angeles County. The provision of this paragraph shall survive expiration or other termination of this Agreement regardless of the cause of such termination.

20. Documents:

All drawings, specifications, documents and other memoranda or writings relating to the work and services hereunder, shall remain or become the property of the DISTRICT whether executed by or for the CONTRACTOR for DISTRICT, or otherwise by or for the CONTRACTOR, or by or for a subcontractor operating under the CONTRACTOR'S supervision, or direction, and all such documents and copies thereof shall be returned or transmitted to DISTRICT forthwith upon DISTRICT written demand, termination or completion of the work under this Agreement.

21. Data Security – Confidentiality

a. Acknowledgment of access to information characterized as covered data

Contractor acknowledges that its contract/purchase order (“Agreement”) with the DISTRICT may allow the Contractor access to confidential DISTRICT information or DISTRICT provided information including, but not limited to, personal information, records, data, or financial information notwithstanding the manner in which or from whom it is received by Contractor (“Covered Data”) which is subject to state laws that restrict the use and disclosure of DISTRICT information, including the California Information Practices Act (California Civil Code Section 1798 et seq.), California Constitution Article 1, Section 1, and other existing relative or future adopted State and/or Federal requirements. Contractor shall maintain the privacy of, and shall not release, Covered Data without full compliance with all applicable state and federal laws, DISTRICT policies, and the provisions of this Agreement. Contractor agrees that it will include all of the terms and conditions contained in this clause in all subcontractor or agency contracts providing services under this Agreement. Where a federal, state or local law, ordinance, rule or regulation is required to be made applicable to this Agreement, it shall be deemed to be incorporated herein without amendment to this Agreement.

b. Prohibition on unauthorized use or disclosure of covered data and information

Contractor agrees to hold Covered Data received from or created on behalf of DISTRICT in strictest confidence. Contractor shall not use or disclose Covered Data except as permitted or required by the Agreement or as otherwise authorized in writing by DISTRICT. If required by a court of competent jurisdiction or an administrative body to disclose Covered Data, Contractor will notify DISTRICT in writing prior to any disclosure in order to give DISTRICT an opportunity to oppose any such disclosure. Any work using, or transmission or storage of, Covered Data outside the United States is subject to prior written authorization by the DISTRICT.

c. Safeguard standard

Contractor agrees that it will protect the Covered Data according to commercially acceptable standards and no less rigorously than it protects its own confidential information, but in no case less than reasonable care. Contractor shall develop, implement, maintain and use appropriate administrative, technical and physical security measures which may include but not be limited to encryption techniques, to preserve the confidentiality, integrity and availability of all such Covered Data.

d. Return or destruction of covered data and information

Upon termination, cancellation, expiration or other conclusion of the Agreement, Contractor shall return the Covered Data to DISTRICT unless DISTRICT requests that such data be destroyed. This provision shall also apply to all Covered Data that is in the possession of subcontractors or agents of Contractor. Contractor shall complete such return or destruction not less than thirty (30) calendar days after the conclusion of this Agreement. Within this thirty (30) day period, Contractor shall certify in writing to DISTRICT that the return or destruction has been completed.

e. Reporting of unauthorized disclosures or misuse of covered data and information

Contractor shall report, either orally or in writing, to DISTRICT any use or disclosure of Covered Data not authorized by this Agreement or in writing by DISTRICT, including any reasonable belief that an unauthorized individual has accessed Covered Data. Contractor shall make the report to DISTRICT immediately upon discovery of the unauthorized disclosure, but in no event more than two (2) business days after Contractor reasonably believes there has been unauthorized use or disclosure. Contractor's report shall identify: (i) the nature of the unauthorized use or disclosure, (ii) the DISTRICT Covered Data used or disclosed, (iii) who made the unauthorized use or received the unauthorized disclosure, (iv) what Contractor has done or shall do to mitigate any deleterious effect of the unauthorized use or disclosure, and (v) what corrective action Contractor has taken or shall take to prevent future similar unauthorized use or disclosure. Contractor shall provide DISTRICT other information, including a written report, as reasonably requested by DISTRICT.

f. Examination of records

DISTRICT and, if the applicable contract or grant so provides, the other contracting party or grantor (and if that be the United States, or an agency or instrumentality thereof, then the Controller General of the United States) shall have access to and the right to examine any pertinent books, documents, papers, and records of Contractor involving transactions and work related to this Agreement until the expiration of five years after final payment hereunder. Contractor shall retain project records for a period of five years from the date of final payment.

g. Assistance in litigation or administrative proceedings

Contractor shall make itself and any employees, subcontractors, or agents assisting Contractor in the performance of its obligations under the Agreement available to DISTRICT at no cost to DISTRICT to testify as witnesses, or otherwise, in the event of litigation or administrative proceedings against DISTRICT, its directors, officers, agents or employees based upon a claimed violation of laws relating to security and privacy and arising out of this Agreement.

h. No third-party rights

Nothing in this Agreement is intended to make any person or entity who is not signatory to the Agreement a third-party beneficiary of any right created by this Agreement or by operation of law.

i. Attorney's fees

In any action brought by a party to enforce the terms of this Agreement, the prevailing party shall be entitled to reasonable attorney's fees and costs, including the reasonable value of any services provided by in-house counsel. The reasonable value of services provided by in-house counsel shall be calculated by applying an hourly rate commensurate with prevailing market rates charged by attorneys in private practice for such services.

j. Survival

The terms and conditions set forth shall survive termination of the Agreement between the parties.

22. Entire Agreement and Modification:

This Agreement and all documents incorporated by reference supersedes all previous Agreements either oral or in writing and constitutes the entire understanding of the parties hereto. No changes, amendments or alterations shall be effective unless in writing and signed by both parties.
